7. All spare part supersessions must be declared in the quotations sent out by ST Logistics. Vendors must furnish the supersession letters from OEM/Authorised agent/distributor upon request by ST Logistics.
8. Engineering changes must be declared in the supersession letter. If there are engineering changes, the details on the engineering changes must be provided together with the supersession letter. If there are no engineering changes, it must be explicitly stated in the supersession letter that no engineering changes are involved.
9. If supersessions are not declared in the quotations and ST Logistics discovers that the items are superseded upon delivery of goods to ALB, ST Logistics reserves the right to reject the deliveries. ST Logistics will then seek endorsement from user on acceptance of superseded parts. ST Logistics reserves the right to cancel the PO if the supersession is not accepted by user.
10. All lifting equipment must be delivered with PE test certificates.
11. All tools that need calibration must be delivered with calibration certificates which must be valid for one year from the date of delivery to ALB.
12. Language Requirements - All vendors must ensure that all components supplied under this RFQ are programmed and displayed in English. Vendors are required to verify and confirm that their components meet this requirement before quotation and delivery. Failure to comply with the language requirements will result in the vendor bearing all associated costs, including any delays or disruptions caused by non-compliance. By participating in this RFQ, vendors acknowledge that they have read, understood, and agreed to the terms and conditions outlined.
