3、 Qualification Requirements For Bidder
Qualifications or Performance:3.1 The Bidder is legal person or other organization that has purchased the bidding documents from the Tenderer or the Tendering Agent, and participated in the bid. Any legal person or organization that has not purchased the bidding documents from the Tenderer or the Tendering Agent is not allowed to participate in the bid.
3.2 This Invitation for Bids is open to all legal persons or other organizations from within the People's Republic of China (hereinafter abb. as "PRC") and all countries/areas which have regular trade relations with PRC (hereinafter called "the eligible source countries/areas"), except as provided hereinafter.
3.3 Any legal person or other organization that has conflict of interest with the Tenderer and may have impact on fairness of the bidding is not allowed to participate in the bid.
3.4 Any legal person or other organization that has been entrusted to provide consulting service at the preliminary stage of the project or to prepare the bidding document is not allowed to participate in the bid, nor to prepare bid documents or provide consulting service to the Bidder.
3.5 Different bidders that have the same person in charge or have the relationship of share-holding or management should not participate in the bids for the same package except for the case to form a joint venture to bid.
3.6 The Suppliers may participate in the bids only if they are legally and financially autonomous, if they operate under relevant law, and if they are not a dependent agency of the Tenderer or the Tendering Agent.
3.7 Bidders should successfully complete registration on <http://www.chinabidding.com> (hereinafter abb. as "the Website") prior to the deadline for submission of bids stipulated in the bidding document. Otherwise, the bidders cannot enter into bidding procedures, and any consequence arisen thereafter shall be borne by bidders.

3.8 Joint Venture is permitted for the Bid. Any party to a joint venture shall not, for the same package, submit bid independently in its name or participate in another joint venture.

3.9 Agent is NOT permitted for the Bid.

3.10 The Suppliers shall meet at least one of the following conditions:

1) The Suppliers from outside China Customs territory must have completed registration in accordance with China's Nuclear Safety Regulations "Regulations on the Supervision and Administration of Imported Civil Nuclear Safety Equipment" (HAF 604) and provide supporting documents. The documents should include registration scope table. The scope of registration of equipment type shall cover the purchasing equipments (plate heater exchanger Safety class 3).

2) The Suppliers from within China Customs territory must have successfully applied for a permit in accordance with the provisions of the Chinese Nuclear Safety Regulations, Civil Nuclear Safety Equipment Design, Manufacturing, Installation and Non-destructive Inspection Supervision and Administration (HAF601), and provide supporting documents. The documents should include a list of permitted activity scope. The scope of the permit of equipment type shall cover the purchasing equipments (plate heater exchanger Safety class 3).

3.11 Bidders and their Joint Venture Members shall not be under any of the following circumstances:

1) having been recognized as bid-rigging and collusion behavior by CNNC electronic procurement platform.

2) being listed on the supplier blacklist or greylist of CNNC, the Tenderer, and has not yet been removed from that list;

3) having been included in the Tenderer's list of supplier with undesirable conduct as a potential supplier and not yet removed from such list;

4) having been explicitly ordered to suspend work by the nuclear safety regulatory authority due to non-compliance with the "two zero-tolerance" requirements of nuclear safety supervision.
