Enclosed is a Request for Quotations (RFQ) for trash and recycling collection services for Embassy compound and warehouse. If you would like to submit quotation, follow the instructions in Section 3 of the solicitation, complete the required portions of the attached document, and submit it to the address shown on the Standard Form 1449 that follows this letter.

The U.S. Government intends to award a contract/purchase order to the responsible company submitting an acceptable offer at the lowest price. We intend to award a contract/purchase order based on initial quotations, without holding discussions, although we may hold discussions with companies in the competitive range if there is a need to do so.

The Embassy intends to conduct a pre-quotation conference at the site; The pre-proposal conference will be held on **February 19, 2026, at 10:00 a.m. (4:00 a.m.(morning) Addis Ababa time)** at the U.S. Embassy, Addis Ababa. Prospective offerors/quoters should contact addiscontract@state.gov no later than **2:00 p.m. (08:00 p.m. (afternoon) Addis Ababa time)** on **February 17, 2026** for additional information or to arrange entry to the building.

Quotations are due by **March 03, 2026, at 10:00 a.m. (4:00 a.m.(morning) Addis Ababa time)**. No quotations will be accepted after this time. Proposals must be in English and incomplete proposals will not be accepted.

Submit your bids in two separate folders, financial and technical. Include Solicitation number **19ET1026Q0001** in the subject line of your email for questions and offer submissions.

Your quotation must be submitted electronically to addiscontract@state.gov. It is important to make sure the submission is made in specific size and format; in MS-Word 2007/2010 or MS-Excel 2007/2010 or Adobe Acrobat (pdf) file format. The file size must not exceed 30MB. If the file size should exceed the 30MB, the submission must be made in separate files and attached to separate emails with less than 30MB each.

In order for a quotation to be considered, you must also complete and submit the following:

1. SF-1449
2. Section 1, Pricing
3. Section 5 Representations and Certifications
4. Additional information as required in Section 3
5. Proof of SAM Registration

Offerors shall be registered in the SAM (System for Award Management) database at <https://www.sam.gov> prior to submittal of their offer/proposal as prescribed under FAR 4.1102. Failure to be registered at time of proposal submission may deem the offeror's proposal to be considered non-responsible and no further consideration will be given. Therefore, offerors are highly encouraged to register immediately if they are interested in submitting a response to this requirement.

System updates may lag policy updates. The System for Award Management (SAM) may continue to require entities to complete representations based on provisions that are not included in agency solicitations. Examples include 52.222-25, Affirmative Action Compliance, and paragraph (d) of 52.212-3, Offeror Representations and Certifications—Commercial Products and Commercial Services. Contracting officers will not consider these representations when making award decisions or enforce requirements. Entities are not required to, nor are they able to, update their entity registration to remove these representations in SAM.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

BACKGROUND

The U.S. Embassy Addis Ababa requires Trash Collection and Recycling Services from a contractor to collect and properly dispose or recycle refuse, in an approved landfill or recycling facility, from the Embassy Compound and Warehouse three times per week, according to a schedule provided by the COR (additional collection could be requested by the COR, as needed). The contractor will provide adequate labor, commercial trash collection vehicles / container lift trucks, and truck driver to load, pick-up the trash and empty the bins. Contractor shall provide a monthly paid receipt from the approved landfill or collection facility.

GENERAL PROJECT REQUIREMENTS

The Contractor shall provide all necessary labor, supervision, management, transportation, and equipment necessary to collect all refuse and recycling from the Embassy Compound and Warehouse three (3) times per week.

SCOPE OF SERVICES

Exterior Trash Collection Services at Embassy Compound:

- Contractor shall supply appropriate type and sized bins according to the demand at the collection site. Contractor shall replace broken bins, as needed. The Contractor shall clean (interior and exterior) each bin, as needed.
- Commercial trash collection vehicles / container lift trucks, and truck driver to load, shall be provided to pick-up the trash and recycling.
- The Contractor shall schedule all routine pick-ups during normal building hours which are defined as 07:30 to 16:00 Monday to Thursday and Friday 07:30 to 11:00, excluding local and U.S. holidays, and approved in advance by the U.S. Embassy Contract Officer Representative (COR).
- The Contractor shall provide monthly and annual weight (kg/pounds) reports on the number of collections and receipts demonstrating refuse was properly dumped at an appropriate landfill or collection facility.
- The Contractor shall be required to work under rigid safety measures
- Contractor shall collect trash, refuse, and recycling materials from the Embassy Compound three (3) times per week.

- Contractor shall load trash and refuse from the trash enclosure area, as shown of diagram below, from the outside the property (SCAC). If required to enter the compound, vehicles must be registered, 48-hours in advance, all contractor personnel must provide adequate identification and shall be subject to a check (in and out) by guard personnel, and escorted by assigned person.

Recycling Services and Pick-Up

- Contractor shall perform recycling work, including furnishing all labor, materials, equipment, and services
- Contractor shall collect and properly recycle the following materials: cardboard (all types) and shredded paper
- The contractor shall supply the bins, pallets, or proper collection containment according to the demand for the recycled waste for use at the collection site.
- The Contractor shall provide monthly and annual weight (kg/pounds) reports on the number of recyclables collected for each material, as applicable.
- The Contractor shall affix signage on each bin to denote the type of waste or recyclables which they are designated to receive, as applicable.
- All refuse on the ground shall be picked up by the Contractor during collection of recycled waste. The Contractor shall be responsible for keeping the collection area free of refuse and debris.
- The Contractor shall deep clean (interior and exterior) each bin as needed
- The Embassy will be responsible for separating the trash into different material piles.

GENERAL INFORMAIION

Contractor is responsible for ensuring the area and trash enclosure shall be maintained in a clean manner at the end of each pick-up. Contractor should clean and restore area to its original or better condition at the completion of the cleaning.

Unless otherwise agreed with the COR, pick-up should be executed during normal Embassy work hours, 07:30 to 16:00 Monday to Thursday and Friday 07:30 to 11:00, taking American and Ethiopian holidays into account.

The work shall be executed in a diligent and work with manner in accordance with the negotiated fixed price, this Scope of Work and schedule.

The Contractor shall provide all supervision and labor needed to perform the work outlined in this scope of work. The Contractor shall provide on-site supervision and visit the project regularly.

Employees are expected to comply with reasonable dress and grooming standards. Attire shall be in good repair and not be considered offensive, disruptive, or unsafe. The Government is authorized to restrict facility access to any contractor employee who is identified as a potential threat to the health, safety, security, general well-being, or operational mission of the installation and its population.

Smoking is prohibited within 30 ft of any entrance; and/or within fifty (50) feet of flammable or combustible liquids. Smoking is permitted **only** in the designated smoking area.

The Contractor shall be responsible for conducting the work in a manner that ensures the safety of employees, visitors, and the Contractor's employees

Contractor shall comply with Safety Standards that are applicable to trash collection services.

The Contractor shall establish and maintain a detailed plan or standard operating procedure for Accident Prevention, Safety, and Health (Contractor's Safety Plan). The Contractor's Safety Plan shall clearly designate the "Competent Person" who is overall responsible for job-site safety. The Competent Person means a person – because of knowledge, skill, training, and experience – who can identify existing and predictable hazards in the surroundings or working conditions which are unsanitary, hazardous, or dangerous to employees.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause ([FAR 52.212.4](#), Contract Terms and Conditions - Commercial Products and Commercial Services (NOV 2023), if any of the services exceed the standard.

3. PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. The Contractor should revise each IRS Form W-14 submission to reflect the exemption (if any) that applies to that particular invoice, such as a different exemption applying.
