The requirements for data processing and deliveries are described in the instructions. The project includes testing a stream of data. 20% of the total price shall be used for testing the directorate's NIN app and MarinWeb, which shall then be used in the mapping process. Parallel with the mapping in Askøy, the same type of mapping will be run with tests of data flow in Stavanger municipality. In the tender round, all can apply for both projects, but the Norwegian Environment Agency will choose different operators for respectively. Askøy and Stavanger.
